



LIMU Experience Story Submission Official Terms & Conditions

GENERAL GUIDELINES:

- Contest qualification period is approximately every 120 days.
- Prizes will be awarded at the event following the end of the qualification period.
- A participant may begin their Experience Story any day of their choosing and there is no time limit.
- A participant's Experience Story submission date will determine the qualification period.
- A participant may enter one story per qualification period with no limit on submissions. The updated story must be different for each submission.

ELIGIBILITY:

- Contest is open to all new and existing U.S. and International LIMU Promoters and Customers.
- Participant must be 18 years of age or older.
- Participant must be in good standing with the company throughout the qualification period.
- Participant must have an automatic monthly order (Customers) or active AutoShip of 100PV or more (Promoters) and use one or more LIMU products during their LIMU Experience.
- AutoShip must be active from their start date through reward presentation.

WEIGHT LOSS ONLY

- Participant must be truthful and accurate in your measurements and photos submitted.
- Participants cannot use surgical means to reduce his/her weight (like Bariatric Surgery). If you undergo surgery to reduce your weight, you should withdraw from the contest or you will be disqualified.

SELECTION:

- LIMU will award winners at a LIMU event approximately every 120 days each year.
- Each participant must submit his/her results, photo(s) if required, and final story before the qualification deadline, which is posted on our website at www.thelimuexperience.com.
- Winners must be registered for the event and present to win. No notification prior to the event will be made.

- Winners must be available for additional photography at the end of the event, as requested.

WEIGHT LOSS ONLY
